The National Human Rights Commission (NHRC) in collaboration with the Indian Law Institute (ILI) is organizing a **two-day training Programme for Police Personnel** on **23-24 August, 2025** in the Indian Law Institute, New Delhi. The theme of the programme is "**Police and Human Rights: Issues and Challenges**" for the middle-level police officers.
